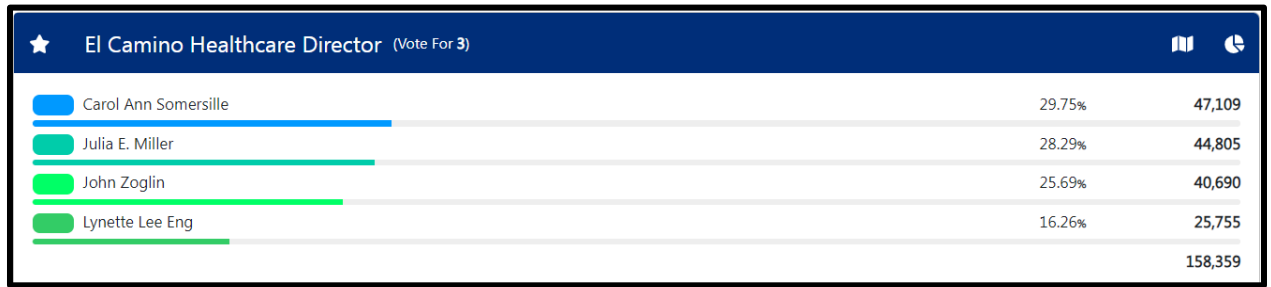

Subject: Acceptance of the Santa Clara County Election Results of the November 5, 2024 Election

Recommendation(s):

To accept the Santa Clara County Election Results of November 5, 2024.

Summary:

- Situation:** Four individuals filed Declarations of Candidacy for the three four-year term vacancies to be filled with the November 2024 election. As December 5, 2024 the Santa Clara County Registrar of Voters reported (per its website) that ballots were counted and candidate Carol Ann Somersille, MD, received 47,109 votes (29.75%), candidate Julia E. Miller received 44,805 votes (28.29%) and candidate John Zoglin received 40,690 votes (25.70%). The next closest candidate received 25,755 votes (16.26%).



- Authority:** The Santa Clara County Registrar of Voters ("ROV") certified the November 5, 2024 election results on December 5, 2024 and made Certificates of Election available that afternoon.

EL CAMINO HEALTHCARE DISTRICT RESOLUTION 2024-14

WHEREAS, the Uniform District Election Law, California Elections Code section 10544, requires that elective officers, elected or appointed, take office at noon on the first Friday in December next following the general district election, and that prior to taking office, each elective officer shall take the official oath; and

WHEREAS, Government Code section 1360 requires all elected or appointed officers to take and subscribe the oath or affirmation set forth in Article XX of the California Constitution; and

WHEREAS, Government Code section 1362 states that the “oath may be taken before any officer authorized to administer oaths;” and

WHEREAS, Government Code section 1225 states that an “executive officer, a judicial officer, and a Member of the legislature may administer and certify oaths;” and

WHEREAS, Government Code section 1001 states that civil executive officers includes “such other officers as fill offices created by or under the authority of charters or laws for the government of counties and cities or of the health, school, election, road, or revenue laws; or persons serving on boards and commissions created under the laws of the state or established under the State Constitution;” and

WHEREAS, the Uniform District Election Law, California Elections Code section 10512(b) states that the county elections official or district secretary, or a “person designated by” the county elections official or district secretary, may administer the oath or affirmation set forth in Section 3 of Article XX of the California Constitution to the candidate elected to office; and

WHEREAS, the El Camino Healthcare District Board of Directors is committed to ensuring proper procedures for the administration of the oath of office for elected and appointed officials as required under applicable laws; and

WHEREAS, the El Camino Healthcare District Board of Directors, including the district secretary desire to designate individuals authorized to administer oaths to elected and appointed officials of the El Camino Healthcare District.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors as follows:

1. **Authority to Administer Oaths.** Any elective officers of the El Camino Healthcare District Board of Directors, the United States of America, the State of California, and any city, district, or county located within the State of California, is hereby authorized



to administer the oath of office to any individual required to take and subscribe to such an oath under applicable law, including but not limited to, elected or appointed officials of the El Camino Healthcare District. For purposes of this resolution, “elective officers” means any officer of a local, state, or federal agency, or political subdivision, holding an office that can be filled by election pursuant to state or federal law.

2. **Scope of Authority.** This authority shall be exercised in accordance with applicable laws and procedures, and in furtherance of the official duties of the elected official administering the oath.
